(A Brief History)

The highest educational goal of a nation is to create ideal citizens and individuals who are capable of fulfilling their own goals and striving to create a progressive society. With this vision of Man-making, Vivekananda Senior Secondary School was established in the year 2003, by Sri N. C. Paul at Chengkuri Road, Silchar 7. In his sacred endeavour, he was inspired by his friend Dr. P. Nath Choudhury, former Principal of G.C. College. The School was inaugurated by Prof. Subhas Saha, the former Vice Chancellor of Assam University Silchar

Vivekananda Senior Secondary School is a co-educational school affiliated to Assam Higher Secondary Education Council (AHSEC). The School seeks to provide education to all sections of the society, irrespective of religion, caste or community. The School is managed by a Managing Committee. The Committee comprises of a group of eminent persons of Silchar town. It is constituted under the provision of Assam Non Government College Management (Amendment) Rules 2009 and it reserves the rights in all matters related to educational, administrative and management policies.

Two Year Higher Secondary courses:

The School offers H.S. course in Commerce, Arts and Science streams. The H.S. course comprises of two examinations viz. H.S. 1st year and H.S. 2nd year respectively and its examinations are conducted following all the rules and regulations prescribed by the Assam Higher Secondary Education Council, Guwahati-21.

In spite of its humble beginning, the spectacular performance of the students of this college in the H.S. Examination 2008, infused the movement to introduce the Arts stream in 2008.

Again, catering to a massive public demand, the school authorities have introduced the much awaited Science stream in 2014 and now it has become a full-fledged Senior Secondary School of Arts, Science and Commerce streams.

Aims and Objectives:

The aim of Vivekananda Senior Secondary School is to help students develop into successful human beings. It seeks to help the students to attain physical, cognitive and moral development. It also aims for the development of independent thinking and democratic attitude and cultivate an ardent determination and exceptional skill to face any odds and challenges of life. The School also aims to cultivate respect, dignity, modesty, discipline and all such values which enrich our culture and make a better society.

With sincerity and utmost dedication, the School seeks to provide the best of guidance to the students.

General Rules and Regulations of the School:

- 1) **Attendance:** 75% attendance is a must. 60% and above but less than 75% attendance will be treated as non-collegiate and may be considered only on legal guardians (Father/Mother) undertaking to establish the genuineness of the case with valid supporting documents and if justified to consider will have to pay a fine of Rs. 5,000/- (Five Thousand) only. Less than 60% attendance does not fall under the purview of consideration for any reason(s) whatsoever.
- 2) **Leave on Medical Ground:** Only if one be hospitalized / unable to move for sudden physical disorder, may apply for leave on medical ground with various supporting documents in addition to medical certificate as a proof for genuineness of the respective case. Under such condition maximum 10-15 days leave on medical ground may be allowed for attendance purpose only. No leave on medical ground be allowed for any other purpose(s) / reason(s) whatsoever.
- 3) **Rules to Sit in Unit Tests:** Two Unit Test(s) is mandatory. If one remains absent for more than two days in a week will not be allowed to sit in the Unit Test. Students remaining absent for 2 days in a week, legal guardians (Father / Mother) are to inform the reason(s) of absence in writing otherwise the defaulting students will not be allowed to sit in the Unit Test. Attendance of students will be taken at the end of each week to ascertain the qualifying attendance to sit in the Unit Test at the beginning of next week.
- 4) **Unit Test(s) (The Qualifying Test to Filling up the H.S. Final Examination Form):** Each subject in the Unit Test(s) will carry 30 (Thirty) marks and the qualifying marks in each subject will be 9 (Nine) marks for all streams. None will be allowed to fillup the “**H.S. Final Examination Form**” unless appears in all subjects in the Unit Test(s) and obtain the qualifying 9 (Nine) marks as stated above.
- 5) No students will be allowed to enter the School premises without wearing college uniform either for attending classes or for any other official purpose.
- 6) No student will be allowed to use “**Mobile Phone**” inside the School campus. If any student is found using “**Mobile Phone**” inside the School campus, his/her mobile will be seized for the entire session and mobile phone will be handed over to the parents at the end of the session.
- 7) Students, if caught doing any unfair means inside the School campus will be punished.
- 8) If any student is found chewing of “**PAAN OR any kind of GHUTKA**” etc., **a fine of Rs.500/-** will be charged and also **suspended from attending classes atleast for a month.**

- 9) If any property of the School is will fully damaged by the student(s), the loss caused shall be recovered either directly or by any other means from the student(s) as the School authority deems fit and proper.
- 10) Boys' hair – cut and hair – style should be normal. Parents are requested to look into the hair – cut and hair – style of their wards. Peculiar hair – cut and hair – style and peculiar type(s) of wearing of School uniform and wearing any type of foot wear other than **Black shoe** will not be entertained and such unruly students will not be allowed to attend classes.
- 11) Girls' making any peculiar hair colour, peculiar type(s) of wearing college uniform and wearing any type of foot wear other than **Black shoe** will not be entertained and such unruly students will not be allowed to attend classes.
- 12) In any case no excuse / consideration / persuasion will be entertained on any matter particularly on the qualifying attendance to sit in the Unit Test(s) / marks to be obtained in Unit Test(s) for any reason (s) whatsoever.
- 13) In spite of prior circulation for intimation of the rules in writing to the students and their parents and also face to face discussion in detail in the "Guardians Meet" at the beginning of the session, the School may not be held liable for anything otherwise so happens during the courses of studies in the School.

Admission Procedure for H.S. (Commerce, Arts and Science)

- a) The Admission Committee of the School reserves its rights in all matters related to the admission of the students. The decision of the committee is final.
- b) Application for admission should be made in prescribed admission form. The admission form will be available in the college office on payment of Rs. 100/-. The prospectus and application form are available only in School Office.
- c) Admission forms for the H.S. 1st year are generally made available immediately after the declaration of the results of the H. S. L. C. Examinations. Information related to the norms, date of admission and submission of forms will be displayed on the School Notice-Board.
- d) The admission form must be filled up with utmost care, for no subsequent changes will be entertained.
- e) **ATTESTED COPIES OF THE FOLLOWING DOCUMENTS ARE TO BE SUBMITTED ALONG WITH THE APPLICATION FORM.**
 - i. Admit card, Marks-sheet and Registration Certificate from H.S.L.C onwards.
 - ii. Character Certificate issued by the school /College Authority where he /she last attended /studied.
 - iii. Two copies of passport-size photographs.
 - iv. Migration Certificate in original for applicants of CBSE and other State- Boards.
 - v. Gap-period certificate from authorized person if the student has passed the qualifying examination one year earlier than the current year.

(Note: A candidate who has passed the qualifying examination earlier than the current year has to produce a gap-period certificate issued by the Head of the institution last attended or by a gazetted officer regarding his activities during the gap period.)

- f) On the day of interview and admission, the students have to furnish the original documents for verification.
- g) Parents are asked to inform the School authority whenever there is a change in the address or contact numbers.
- h) Fee structure (per annum) will be notified along with the admission notice after publication of HSLC results.
- i) Admission fees etc. paid at the time of admission are non-refundable for any reason(s) whatsoever.

Change of combination /subjects:

Change of combination /subject(s) is not encouraged and therefore the candidates are advised to think deeply while selecting their subjects or combination at the time of filling up the prescribed form for admission, If in extreme case, a student has to change his/her combination /subject, he /she has to apply to the Principal within one month of his/her admission. The change of combination /subject(s) is applicable to H.S. 1st year only.

Enrolment in the School implies, on the part of the students and guardians, to comply with the rules and regulations of the School.

Library:

The School provides a well furnished library. Students are provided with Borrower's card which facilitates them not only to borrow books but also to read journals and periodicals. However, students are advised to go through the rules & regulations of the library before they avail the facilities.

Uniform of the Students:

The uniform of the students will be supplied by the School to maintain uniformity of quality and colour. The purchase of uniform from the college is compulsory. Wearing of complete uniform is a must. No student will be allowed to enter the School without complete uniform. Students must follow the details given below:-

For Boys

- a. Shirt in pink colour
- b. Tie in grey.
- c. Trousers in grey.
- d. Socks in white colour.
- e. Black shoes (normal shape)
- f. Black belt
- g. Sweater in grey (either half or full)

- d) Socks in White
- e) Cardigan in grey

Students are not allowed to wear low-waist trousers / pants.
